





NVUSD Property Locations




City influence on NVUSD Properties

- Some properties do not have land use consistent with the use (ie: AC Middle School is designated Residential, new Elementary School is designated Commercial Recreation)
- The District may want surplus properties redesignated (ie: Napa Junction Elementary school is designated Public)

NVUSD Student Generation

- The city may redesignate properties to a different land use or allowable density.
- These redesignations may impact student generation in the future.
- As a major landowner, the City will meet with the NVUSD to discuss the future of their properties as a normal component of the General Plan Update outreach.

FYI – No specific action on the part of the ELL Committee other than knowledge that General Plan policies have many interrelated impacts across issues.
